He now alleges that those very studies were manipulated and fraudulent, intentionally managed so that parents were not told the truth - that vaccines can, and do, cause autism. Because much of the book is a direct transcript of various phone conversations, it is sometimes a little confusing, but the author then does a good job of giving an overview of the whistleblower case. It will now be interesting to see how this story progresses. The author's plea is that parents, outraged by this intentional policy of lies and deception, spread the story themselves, through social media and word of mouth. For sure, mainstream media wont' touch it, and if they do, they will pay lip-service to their Pharma masters. Just watch these reviews!
