

VERY USEFUL, CLEAR AND CONCISE.-

I'm a third year medical student and I bought this book as my main resource to prepare for the neurology clerkship shelf exam. It took a long time to get through, and the format takes a awhile to get used to. For each disease topic/chapter there is random babble about history and physical exam, then there is a long differential, followed by the briefest of explanations of each disease in the differential. I would prefer a text that told me everything I need to know about each disease, like say, multiple sclerosis. But in this book you learn that MS can cause seizure in one chapter, vision problems in a another chapter, and corticospinal tract demyelination in another. It is therefore difficult to piece together all the findings when you are presented with a test question having all 3 signs tied into it. When I started doing pretest questions I was completely lost. I don't know what a good neuro book is but this one sure is not. To think it is rated highly in the back of the First Aid for the Wards book, I can't understand why. The neuro section of step up to medicine is pretty good,

and the pretest book is as usual quite good. Don;t waste your money on this one, try another.

This book is honestly the worst text book I have ever had to read. I love neurology and the formatting of the book makes learning the material miserable.

This text is a good introduction to clinical neurology. It is especially useful to residents, since it can be read in a few days and shows how to approach the most common syndromes. Unfortunately, the sections on individual diseases include important omissions and are often out-dated.
