

This text is well written and presented. It is clear, organized, and generally easy to read without boring me to tears. I bought the 8th ed. even though my course assigned the 9th, because this version is so cheap it's practically free. I've looked at the 9th ed. that all my classmates bought (and paid \$90+) and the two are so similar that the new version is most certainly not worth the extra expense. Just make sure you check the subjects on the chapters in your syllabus, as some do not match up with the 9th ed.I highly recommend you buy this version in place of the new one!

This book was required for my nursing school - BSN program. I feel the selection of books my program chose were all very informative, to the point and we used the books for the classes that required them. During nursing school most people do not know where their career will take them, there are so many options the RN has available, so building a strong foundation is essential to success in the field. Nursing books are not written to be entertaining they are for educational purpose only. This book definitely offered education. After you graduate school and chose a path then find the best reference book you can find and carry it with you until the day you retire. I always recommend the additional study guide to a book if one is available.

I had to buy this for a nursing class, but even though it covers the field I want to work in, I will NOT be keeping this as a reference book. The organization of information in this book is confusing and illogical. One has to scan four chapters to get information on a single pregnancy complication. It's unfortunate that this was the textbook of choice for my class. I would have rathered spend my money and time getting into a book I could reference for years to come.

Almost every topic is discussed in two or more separate places. Sometimes the information is

redundant, sometimes you have to combine the information from different parts of the book to define a term, for example, subinvolution is introduced on page 1042, then discussed more on page 1162. Same information is given about breastfeeding in two separate places. The contents are so disorganized that this textbook is my most hated text book.

This book is an excellent source of information when it comes to OB. I am very pleased with how the content is easy to understand. The pictures are a great source of information. This by far is the best book a student can purchase for nursing school in your OB rotation. This book went right along on how the teacher explained it to us.
