

The book does a great job of explaining the ins & outs of wills, health-care proxies, living wills, and powers of attorney, and introduces the idea of a digital diary for someone to wrap up all your various digital accounts should you become incapacitated or die. I found myself dog-earing many pages and wanting to show it to my husband. We're both 55 and have not done any of our important paperwork and, through the many "horror story" anecdotes in this book, have now been woken up. The 6 "what to do now" steps listed on page 96 are worth the price of the book alone, and the appendix of the book offers samples of each doc, which is very helpful, too. I suspect that by doing our will now, at age 55, this won't be the last time we have to deal with these essential docs, but at least this book has helped us get the show on the road.
