

Good discussions of major topics. Just make sure you review the actual discussion in the answer and not just the letter answers as there are quite a few errors.

It would be so difficult to read this book while I consider many questions as rediculous! Each Question has 5 multiple choice answers. Answers of most of questions are none of the above or all of the above! Some answers are just plain statistics which we do not even care. They do not even mention the location of the pain. They except us to think constipation is the cause!
