

Rutgers Univ. biologist Weis and science writer Butler compile an outstanding study of North

American salt marshes, their natural histories, contributions to human well-being, and what their destruction means from human life and property. After describing the formation and maintenance of coastal marshlands (through tidal and river flows), Weis and Butler discuss in detail the plants and animals that populate marshes, arranged by general complexity, beginning with small invertebrates and insects. Next is a historical overview, introducing the calamitous, long-held belief that marshes are little more than wastelands (the first attempts to "reclaim" marshlands came from European settlers) and a painful exploration of invasive species and their effects. Research data on the widespread benefits of marshlands precede a specific case study, looking at how the Hackensack Meadowlands were destroyed by more than 250 years of "development, drainage, diking, filling, garbage dumping, and sewage pumping." Ongoing restoration projects are also profiled, and the volume concludes with thorough notes. This account should make an informative treat for any armchair conservationist. --This text refers to the Kindle Edition edition.

The authors balance an attention to detail with engaging stories about fiddler crabs, tidal regimes, and other subjects. They also weave important research results into the conceptual storyline, an approach that fosters a broader understanding of what controls

these dynamic systems. The pace and intensity of the prose pick up markedly here, as does the level of detail and documentation. The authors explore the history of the Hackensack Meadowlands as it rose like a phoenix from centuries of neglect and decades of assault, including dumping, filling, polluting, and invading. From the ashes of human abuse and mismanagement came rebirth in the form of salt marsh restoration. The book documents impressive growth in biodiversity and ecosystem function in both terrestrial and aquatic habitats of the Meadowlands, and makes a very compelling case for the future of salt marsh restoration. This is a general introduction to salt marshes, their uses, and their current status, with what amounts to a case study of the Hackensack meadowlands. The writing is good, the science understandable. The most interesting part (to me) is the endocrine disrupters, which may affect various species (including humans) in differing but significant ways. These include pollution originating in birth control pills, tranquilizers, Prozac, statins, as well as the usual array of drugs--excreted in human urine and as inadequately processed sewage, infiltrating the marsh ecosystem. There's plenty else--PCBs, dioxins, oil, polycyclic aromatic hydrocarbons, and general pollution from leaching dumps. The impact of these things on body systems varies but may be vast. There is more than this, but somewhat more general. The book discusses the magnitude of wetland loss, their inherent bioproductivity and environmental value. This last includes breaking waves and absorbing the energy, absorbing waterborne pollution. There's also a rather good section on invasive species, which is a bit scary. Some of the book is a bit technical but it is all accessible.

Four decades ago, John and Mildred Teal published their seminal study of tidal wetlands, Life and Death of the Salt Marsh (1969). They noted: "Marshes are generally considered useless land that

must be made useful as quickly as possible. 'Useful,' of course, means destruction of the marsh in most cases and conversion of the area to ground on which people can stand, and water on which they can float boats." Weis and Butler's book describes the unfortunate results of this traditional view. It also discusses the impact of the recent consensus that salt marshes (the authors' "favorite places for many years") are valuable habitats, worth preserving and restoring. The book's chapters are divided into salt marshes' natural history (1. ecology, 2. plants, and, 3. animals), and their "unnatural" history -- the impact of humans (4. physical alterations, 5. pollution, 6. introduction of non-indigenous species, 7. restoration and management), closing with a case study of the "Death and Rebirth" of northeastern New Jersey's Hackensack Meadowlands. The book is a worthy successor to the Teals' classic work. It is accessible to the general reader, and would be a valuable resource for any college- or graduate-level course dealing with Ecology, Environmental History, or Urban Studies

I purchased this book to familiarize myself with salt marshes before undertaking a cleanup project at Rocky Point marsh, Breezy Point, Queens, New York. It served as a field guide, how-to, history lesson and all-around swamp Bible. The more time I spent at Rocky Point, the more questions I'd formulate about the wildlife, plants and inner workings of the marsh. This book answered all of them and illuminated the many subtleties of this dynamic ecosystem. My project benefits tremendously from this book, which will prove invaluable for anyone interested in salt marshes and their rich and troubled history.
