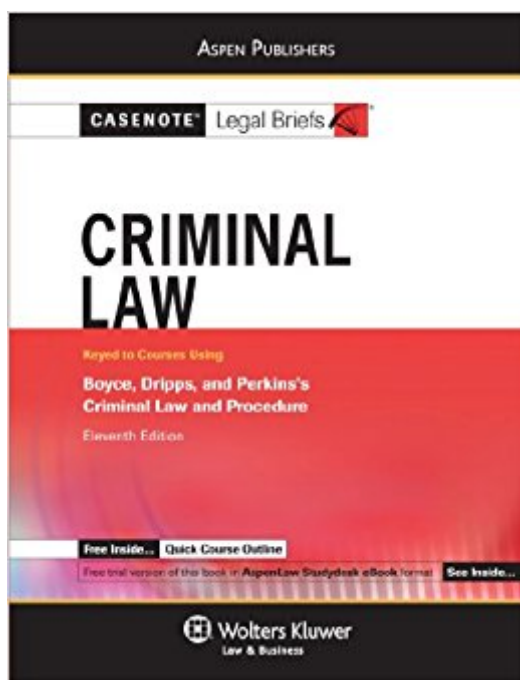

However, these briefs are a good starting point; will a few extra details and rule adjustments (the rule should be different than the issue), this is a worthwhile investment in time management. Also, the pull-out quick reference cards are a good outline refresher. I bought the whole 1L series about 6 weeks in, and my briefing time has gone down dramatically.
