

Dr. Wanlass has out done himself! This manual is a short, easy read, yet packed with useful information. It should be required for students in the introductory neuropsychological assessment class in graduate school; it is very much a "how-to" guide. It takes the reader through the process of neuropsychological evaluations with numerous caveats that give the student a leg up in preventing common errors. The part regarding write-ups is especially comprehensive. It affords the student or newly- licensed neuropsychologist the opportunity to present findings in an accurate, polished and user-friendly manner- a feat that could take others many years to attain. For those who have been practicing for awhile, this book is a wonderful reference guide. The layout is clear and logical, enabling the reader to find relevant pearls quickly. In fact, I bought the book for my book shelf, then purchased the digital version so I can have everything at my fingertips. All I have to do now is pull up the book on my computer and use the search function to zero in on exactly what I am seeking. Dr. Wanlass has literally everything you could imagine regarding options for test selection, phrases for describing findings and report templates for a variety of referral scenarios. He also provides all-important reminders that can help circumvent pitfalls committed by even seasoned

professionals.Referral sources would also benefit from having this guide on hand. It is unfortunate but true that the quality of neuropsych evals varies widely. If you are an attorney, primary care doctor, a medical specialist, or part of the multidisciplinary treatment team, having a gold standard by which to compare the reports you get will open your eyes. Setting the bar high and explicitly stating the referral questions and report expectations can only help propel neuropsychologists up to the level of Dr. Wanlass.For the sake of full disclosure, Dr. Wanlass was my supervisor for my neuropsychology internship almost 20 years ago. Since then, my career has evolved to include more hybrid evaluations in which neuropsychology is a component of what I do. Regardless of the context though, inevitably, I circle back to the education and training I received from him. Now, instead of pestering Dr. Wanlass (which I still do, of course), I can look up my question in his book!

Frequently. Psychologists do not go for descriptive titles when publishing books. Instead they use gotcha titles in an attempt to increase sales or just notice on the bookshelf. A proper title for this manual would be: Publication Manual - Clinical Psychology Version. This volume is an attempt to correct the flaws in reporting writing and planning that go into the writing of clinical reports which must have clinical validity and accuracy in reasoning. This is especially true when these reports are used in courtrooms. There are examples of correct and incorrect judgments and the reasoning behind these. This is a good text to start training with or to use as a refresher. It is brief (160 pages) and as the author states should be utilized as a starting point.
